**Christian, Elam**—Private May 22, 1861. Discharged, disability, Aug. 1, 1861. Enlisted as a private in Co. I, 42d Regt. Ga. Inf. Mar. 10, 1862. No later record.

**Clark, Samuel**—Private May 22, 1861. Took oath of allegiance to U. S. Govt. at Louisville, Ky. and released Feb. 25, 1864.

**Connelly, William C.**—Private May 22, 1861. Transferred to Regimental Band in 1861. Paroled at Farmville, Va. Apr. 11-21, 1865.

**Cook, Issachar**—Private May 22, 1861. Roll for Oct. 31, 1864, last on file, shows him present. No later record.

**Kicklighter, Frederick T.**—Private May 22, 1861. Paroled at Richmond, Va. Apr. 25, 1865.

**Knight, Aaron B.**—Private May 22, 1861. Appointed Sergeant. On detail duty on account of disability Sept. 27, 1864. No later record.

**Knight, J. P.**—Private Feb. 20, 1862. Ordered to report for duty to the Medical Director of hospitals, at Abingdon, Va., being unfit for field service, Mar. 14, 1864. On said detail Oct. 31, 1864. No later record.
