**Moseley, John H. (or Mosley)**—Captain Aug. 24, 1861. Died Jan. 27, or Feb. 1, 1862.

**Moseley, James A. (or Mosley)**—1st Lieutenant Aug. 24, 1861. Resigned May 30, 1862.

**Moise, A. Welborn**—1st Lieutenant. See private, Co. D.

**Holcombe, Thomas**—2d Lieutenant Aug. 24, 1861. Resigned July 21, 1862.

**Keeling, George W.**—Jr. 2d Lieutenant Aug. 24, 1861. Elected Captain Jan. 30, 1862. Resigned on account of age and disability, Aug. 28, 1862.

**Gray, Thomas**—1st Sergeant Aug. 24, 1861. Appears last on roll dated Oct. 31, 1861.

**Hayes, George W.**—2d Sergeant Aug. 24, 1861. Died of typhoid fever in Chimborazo Hospital #3, at Richmond, Va. June 26, 1862.

**Moseley, John C. (or Mosley)**—3d Sergeant Aug. 24, 1861. Elected Jr. 2d Lieutenant Apr. 1862; 1st Lieutenant June 6, 1862. Resigned Sept. 8, 1864.

**Dortch, Lewis**—4th Sergeant Aug. 24, 1861. Elected 2d Lieutenant Sept. 8, 1862. Killed at Spotsylvania, Va. May 12, 1864.

**Whisenant, John N. (or Whistenant)**—1st Corporal Aug. 24, 1861. Reduced to rank in 1863. Deserted Dec. 11, 1863.

**Taylor, Spencer R.**—2d Corporal Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**Farmer, William M.**—3d Corporal Aug. 24, 1861. Elected Jr. 2d Lieutenant Sept. 8, 1862. Wounded and captured at Cold Harbor, Va. June 3, 1864. Died of chronic diarrhoea at DeCamp General Hospital, David's Island, N. Y. Harbor, Sept. 7, 1864. Grave #1838 in Cypress Hill Cemetery.

**Adams, Meed A.**—4th Corporal Aug. 24, 1861. Elected 2d Lieutenant Sept. 8, 1862; Captain of Co. K, 4th Regt. Ga. Reserve Inf. May 10, 1864. Absent without leave from Nov. 25 to Dec. 31, 1864. Paroled at Albany, Ga. May 6, 1865.

**Wilkinson, Thomas (or Wilkerson)**—Musician Aug. 24, 1861. Roll for Aug. 31, 1864, shows him absent without leave. No later record.

**Adams, William R.**—Private Mar. 11, 1863. Died in hospital May 23, 1864.

**Ayres, Moses P.**—Private Aug. 24, 1861. Died May 23, 1862.

**Ayres, Nathaniel P.**—Private Aug. 24, 1861. Died near Richmond, Va. May 25, 1862.

**Ayres, Pleasant B.**—Private Aug. 24, 1861. Died near Yorktown, Va. Apr. 23, 1862.

**Brock, Emory M.**—Private Mar. 1, 1863. Sick in hospital Aug. 31, 1864. Died of measles near Lynchburg, Va. Apr. 11, 1865. Buried there in Confederate Cemetery. No. 10, 1st Line, Lot 193—Christian's.

**Brock, George W.**—Private Aug. 24, 1861. Captured near Sharpsburg, Md. Sept. 18, 1862. Paroled and sent to Winchester, Va. Oct. 8, 1862. No later record.

**Brock, James Marion**—Private Mar. 11, 1862. On detached duty in 1863. Roll dated Jan. 31, 1865, last on file, shows him absent without leave. No later record.

**Brock, John R.**—Private Aug. 24, 1861. Appointed 2d Sergeant in 1863. Captured at Cold Harbor, Va. June 3, 1864. Released at Elmira, N. Y. June 23, 1865.

**Brock, William H.**—Private Mar. 1, 1862. Wounded and captured at Gettysburg, Pa. July 2, 1863. Exchanged. Roll dated Jan. 31, 1865, last on file, shows him present. No later record.

**Busha, Samuel**—Private Aug. 24, 1861. Discharged, disability, Mar. 30, 1862.

**Camp, James D.**—Private Aug. 24, 1861. Reported "sick in hospital" on roll dated Oct. 31, 1861. No later record.

**Camp, Stephen W.**—Private Sept. 22, 1863. Elected Jr. 2d Lieutenant of Co. K, 4th Regt. Ga. Reserve Inf. Apr. 1, 1864. Pension records show he surrendered at Albany, Ga. May 1, 1865. (Born in Franklin County, Ga. Feb. 9, 1843.)

**Carroll, F. M.**—Private Mar. 1, 1862. Captured at Cedar Creek, Va. Oct. 19, 1864. Died at Point Lookout, Md. Nov. 28, 1864.

**Carter, William J.**—Private Aug. 24, 1861. Appointed Sergeant. Captured at Farmville, Va. Apr. 6, 1865. Released at Point Lookout, Md. June 26, 1865.

**Clark, James A.**—Private Nov. 28, 1862. Wounded at Petersburg, Va. June 9, 1864. Absent on furlough Aug. 31, 1864. No later record.

**Clark, Jesse T.**—Private Mar. 9, 1862. Wounded in left arm, necessitating amputation, at Sharpsburg, Md. Sept. 17, 1862. Captured and paroled in 1862. On wounded furlough Aug. 31, 1864.

**Clark, Pleasant G.**—Private Mar. 1, 1862. Roll dated Jan. 31, 1865, last on file, shows him present. No later record.

**Cleveland, John A.**—Private Aug. 24, 1861. Wounded at Fredericksburg, Va. Dec. 13, 1862. Died of wounds in General Hospital #14, at Richmond, Va. Dec. 11, 1862.

**Cleveland, John M.**—Private Aug. 24, 1861. Died in Richmond, Va. hospital prior to July 24, 1862.

**Cleveland, Robert A. C.**—Private Aug. 24, 1861. Appointed Sergeant. Killed at Crampton's Gap, Md. Sept. 14, 1862.

**Cleveland, W. T.**—Private Aug. 24, 1861. Captured at Gettysburg, Pa. July 2, 1863. Paroled at Point Lookout, Md. Feb. 18, 1865. Received at James River, Va. for exchange Feb. 20-21, 1865. No later record.

**Collier, Berry (or Colyer)**—Private. Died in 1863.

**Collier, Russell (or Colyer)**—Private Dec. 22, 1863. Roll dated Jan. 31, 1865, last on file, shows him absent on furlough. No later record.

**Collier, Wiley (or Colyer)**—Private Sept. 22, 1863. Admitted to Jackson Hospital at Richmond, Va., with chronic diarrhoea, July 29, 1864. Furloughed for 30 days Aug. 9, 1864. No later record.

**Collins, C. O.**—Private Aug. 24, 1861. Captured at Gettysburg, Pa. July 2, 1863. Joined 1st Connecticut Cavalry, U. S. A. at Fort Delaware, Del. July 12, 1863.

**Collins, Isham**—Private Aug. 24, 1861. Recommended for discharge on account of disability June 24, 1862. No later record.

**Collins, Moses F.**—Private Aug. 24, 1861. Severely wounded and captured at Sharpsburg, Md. Sept. 17, 1862. Paroled Sept. 30, 1862. Died Nov. 1, 1862.

**Collins, Oliver**—Private Aug. 24, 1861. Furloughed Sept. 10, 1862. No later record.

**Collins, Thomas**—Private Aug. 24, 1861. Captured at Cold Harbor, Va. June 3, 1864. Released at Elmira, N. Y. June 21, 1865.

**Davis, Francis Marion**—Private Aug. 24, 1861. Killed at Cold Harbor, Va. June 3, 1864.

**Davis, James L. M.**—Private Aug. 24, 1861. Died on way home at Anderson, S. C. Mar. 1, 1862.

**Davis, Joel M.**—Private Aug. 24, 1861. Reported "present, sick," on roll dated Oct. 31, 1861. No later record.

**Davis, Robert LaFayette**—Private Aug. 24, 1861. Admitted to Chimborazo Hospital #1, at Richmond, Va. with fever, June 27, 1862, and died July 9, 1862.

**Dean, John T.**—Private Aug. 24, 1861. Wounded and captured at Sharpsburg, Md. Sept. 17, 1862. Paroled Sept. 27, 1862. Roll for Aug. 31, 1864, shows him absent without leave. No later record.

**Defore, Martin**—Private Aug. 24, 1861. Wounded in 1864. Roll dated Jan. 31, 1865, last on file, shows him absent on furlough. No later record.

**Dortch, Newman J.**—Private Aug. 24, 1861. Elected Jr. 2d Lieutenant June 30, 1862; Captain Sept. 8, 1862. Captured at Cold Harbor, Va. June 1, 1864. Died of disease at Fort Delaware, Del. Sept. 25, 1864.

**Dunn, Thomas**—Private Aug. 24, 1861. Killed at Spotsylvania, Va. May 12, 1864.

**Dunn, William R.**—Private Mar. 1, 1862. Roll dated Jan. 31, 1865, last on file, shows him absent without leave. Captured at Greenville, S. C. May 24, 1865.

**Farmer, Thomas H.**—Private Mar. 1, 1862. Captured in 1862. Paroled Nov. 10, 1862. Roll dated Jan. 31, 1865, last on file, shows him on furlough. No later record.

**Farrar, Joel (or Farrow)**—Private Sept. 1, 1862. Captured at Cold Harbor, Va. June 1, 1864. Died of chronic diarrhoea at Elmira, N. Y. Nov. 11, 1864. Grave #823 or 389, Woodlawn National Cemetery.

**Farrar, John W. (or Farrow)**—Private Aug. 24, 1861. Captured in 1861. Died in Washington, N. C. hospital Dec. 8, 1861.

**Fuller, Byron (or Byam)**—Private Mar. 1, 1862. Captured at Cold Harbor, Va. June 3, 1864. Died of acute diarrhoea at Point Lookout, Md. Sept. 4, 1864.

**Fuller, Hiram S.**—Private Aug. 24, 1861. Roll dated Jan. 31, 1864, last on file, shows him present. No later record.

**Gunn, M. P. F.**—Pension records show he enlisted as a private Aug. 1864; was captured, date and place not given, and was en route to Point Lookout, Md. when war closed.

**Hancock, Francis M.**—Private Aug. 24, 1861. Appointed 1st Corporal in 1863. Captured at Deep Bottom, Va. Aug. 16, 1864. Released at Elmira, N. Y. July 26, 1865.

**Hancock, John J.**—Private Aug. 24, 1861. Died of fever in camp Feb. 26, 1863.

**Harrison, John W.**—Private Aug. 24, 1861. Appointed 4th Sergeant in 1863. Captured at Cold Harbor, Va. June 3, 1864. Released at Elmira, N. Y. July 7, 1865. (Born in Georgia in 1841.)

**Haulbrook, Edward B.**—Private Aug. 24, 1861. Roll for Aug. 31, 1864, shows him absent without leave. Pension records show he contracted typhoid pneumonia and was sent to Lynchburg, Va. hospital, and was discharged, disability, Aug. 24, 1864. (Born in Anderson County, S. C. Aug. 1837.)

**Hayes, Larkin H.**—Private Aug. 24, 1861. Discharged, disability, at Richmond, Va. July 26, 1862.

**Hendrix, Willis**—Private Aug. 24, 1861. Admitted to Chimborazo Hospital #3, at Richmond, Va. May 16, 1862. Transferred to Huguenot Springs, Va. May 18, 1862, and died there May 22, 1862.

**Holcombe, Newton J.**—Private Aug. 24, 1861. Appointed 3d Sergeant in 1863. Captured at Deep Bottom, Va. Aug. 16, 1864. Elected 2d Lieutenant Aug. 24, 1864. Released at Elmira, N. Y. June 14, 1865.

**Holmes, Andrew J.**—Private Aug. 24, 1861. Captured at Get-

tysburg, Pa. July 3, 1863. Forwarded from Fort Delaware, Del. to Point Lookout, Md. Oct. 20, 1863. No later record.

**Holmes, George W.**—Private Aug. 24, 1861. Appointed 1st Sergeant in 1863. Captured at Cold Harbor, Va. June 3, 1864. In prison at Point Lookout, Md. and Elmira, N. Y. 1864-1865. Sent to James River, Va. for exchange Feb. 20, 1865. No later record.

**Holmes, Reuben Ezekiel**—Private July 1862. Appears on regimental return for month of Nov. 1862 with remark: "Absent, sent to hospital, time not known." No later record.

**Hunter, Newton J.**—Private Aug. 24, 1861. Deserted Dec. 11, 1863.

**Hunter, William D.**—Private Mar. 19, 1862. Died in Richmond, Va. hospital May 29, 1862. Buried there in Hollywood Cemetery.

**Jennings, Asa M. (or Asa W.)**—Private Aug. 24, 1861. Admitted to Chimborazo Hospital #5, at Richmond, Va. with fever, June 25, 1862. Transferred to Lunchburg, Va. Aug. 7, 1862. Admitted to C.S.A. General Hospital at Danville, Va. with chronic diarrhoea, Aug. 23, 1862, and furloughed for 30 days from Sept. 23, 1862. Died of phthisis in General Hospital, Black & Whites, Va. Sept. 29, 1862.

**Jennings, Ernest**—Private Aug. 24, 1861. Admitted to Chimborazo Hospital #5, at Richmond, Va. with typhoid fever, June 17, 1862, and died June 27, 1862.

**Keeling, Lewis M.**—Private Aug. 24, 1861. Appointed 4th Corporal in 1863. Paid on Sept. 7, 1864, from Mar. 1, to Aug. 31, 1864, while on furlough. Pension records show he was furloughed Aug. 1864, and was physically unable to return to command. Roll for Jan. 31, 1865, last on file, shows him absent on furlough. (Born in Elbert County, Ga. Dec. 26, 1819.)

**Keeling, M. M.**—Private Aug. 24, 1861. Discharged, overage, July 1864.

**Kelley, James B.**—Private Sept. 22, 1863. Deserted Dec. 11, 1863.

**Kelley, Thomas D.**—Private Aug. 24, 1861. Wounded and captured at Deep Bottom, Va. Aug. 16, 1864. Died of variola at Elmira, N. Y. Jan. 5, 1865. Grave #1242.

**Kelley, William H.**—Private Aug. 24, 1861. Wounded and captured at Sharpsburg, Md. Sept. 17, 1862. Exchanged at Aiken's Landing, Va. Oct. 19, 1862. Admitted to Chimborazo Hospital #4, at Richmond, Va., wounded in right foot, Oct. 23, 1862. Furloughed for 30 days Nov. 15, 1862. Died at home, in Habersham County, Ga. Dec. 9, 1862.

**Looney, Thomas M.**—Private Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**McCurdy, David S.**—Private Aug. 24, 1861. Appointed 2d

Corporal in 1863; Sergeant. Surrendered, Appomattox, Va. Apr. 9, 1865.

**Mitchell, Thomas C.**—Private Aug. 24, 1861. Discharged, disability, July 24, 1862.

**Morris, W. Ephraim**—Private Sept. 28, 1862. Roll dated Jan. 31, 1865, last on file, shows him present. No later record.

**Moseley, James H. (or Mosley)**—Private Aug. 24, 1861. Died at Washington, N. C. Jan. 16, 1862.

**Parcelle, LaFayette B. (or Purcell)**—Private Aug. 24, 1861. Wounded and captured at Sharpsburg, Md. Sept. 17, 1862. Died of wounds in hospital in Maryland Sept. 18, 1862. (Born in 1838.)

**Parker, James**—Private Aug. 24, 1861. Died at Washington, N. C. Dec. 25, 1861.

**Parker, Silas D.**—Private Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**Perch, L. B.**—Private. Wounded and captured at Sharpsburg, Md. Sept. 17, 1862. Died at Elias Grove Farm, Md. in 1862. Buried in Confederate Cemetery at Hagerstown, Md.

**Randall, Ira W.**—Private Aug. 24, 1861. Wounded in right arm, necessitating amputation above elbow, at Savage Station, Va. June 29, 1862. (Born in Georgia May 4, 1839.)

**Savage, John, Sr.**—Private Aug. 24, 1861. Roll dated Jan. 31, 1865, last on file, shows him present. No later record. (Born Oct. 14, 1833.)

**Scott, John R.**—Private Aug. 24, 1861. Wounded in 1864.

**Scott, Robert M.**—Private Aug. 24, 1861. Died Aug. 9, 1862.

**Sheriff, Thomas M.**—Private Aug. 24, 1861. Captured at Cold Harbor, Va. June 3, 1864. Died at Elmira, N. Y. Feb. 25, 1865. Grave #2291, Woodlawn National Cemetery.

**Smith, James W.**—Private Aug. 24, 1861. Captured and paroled at Anderson, S. C. May 3, 1865.

**Smith, John Henry**—Private Dec. 28, 1862. Surrendered, Appomattox, Va. Apr. 9, 1865. (Born in Franklin County, Ga. Jan. 9, 1845.)

**Smith, William S.**—Private Aug. 24, 1861. Killed at Crampton's Gap, Md. Sept. 14, 1862.

**Smith, Wilson**—Private Mar. 4, 1863. Absent without leave Aug. 1864. No later record.

**Smith, W. T.**—Private Dec. 8, 1862. Captured at Cold Harbor, Va. June 3, 1864. Transferred from Point Lookout, Md. to Elmira, N. Y. July 17, 1864. Released June 16, 1865.

**Stonecypher, John**—Private Aug. 24, 1861. Discharged, overage, Sept. 17, 1864.

**Stonecypher, John H.**—Private Aug. 24, 1861. Appointed 3d Corporal in 1863. Captured at Cold Harbor, Va. June 3, 1864.

Died of typhoid fever at Elmira, N. Y. Sept. 25, 1864. Grave #365, Woodlawn National Cemetery.

**Stowe, Gilbert**—Private Dec. 28, 1862. Roll dated Jan. 31, 1865, last on file, shows him present. No later record.

**Stowe, Isham**—Private Aug. 24, 1861. Captured at Gettysburg, Pa. July 2, 1863. Died of inflammation of lungs at Fort Delaware, Del. Jan. 28, 1864.

**Stowe, John W.**—Private Dec. 28, 1862. Appointed 4th Corporal in 1864. Roll dated Jan. 31, 1865, last on file shows him present. No later record.

**Stowe, Michael**—Private Aug. 24, 1861. Wounded and captured at Deep Bottom, Va. Aug. 16, 1864. Released at Elmira, N. Y. July 7, 1865. (Born in Georgia.)

**Stowe, Oliver**—Private Aug. 24, 1861. Roll dated Oct. 31, 1861, shows him present, sick. No later record.

**Stowe, Wiley W.**—Private Aug. 24, 1861. Wounded in 1863. Died of wounds in 1863.

**Stowe, William**—Private Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**Summerville, John C.**—Private Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**Terrell, Henry C.**—Private Aug. 24, 1861. Died in Scottsville, Va. hospital Dec. 23, 1862.

**Terrell, William M.**—Private Aug. 24, 1861. Appointed 5th Sergeant in 1863. Captured at Cold Harbor, Va. June 3, 1864. Paroled at Elmira, N. Y. Mar. 14, 1865. Received at James River, Va. for exchange Mar. 21, 1865. No later record.

**Vandivier, Peter S. (or Vandiver)**—Private Aug. 24, 1861. Wounded at Crampton's Gap, Md. Sept. 14, 1862. Returns for Nov. 1862, show he was "At home on furlough without leave; time expired." No later record.

**Vaughn, Robert B.**—Private Mar. 16, 1862. Wounded at Fredericksburg, Va. Dec. 13, 1862. Died Mar. 25, 1864.

**Vaughn, Robert D. L.**—Private Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**Vaughn, R. L.**—Private Mar. 1, 1863. Captured at Deep Bottom, Va. Aug. 16, 1864. Died of chronic diarrhoea at Elmira, N. Y. Feb. 25, 1865. Grave #2990, Woodlawn National Cemetery.

**Wacaster, Samuel (or Wascastle)**—Private Aug. 24, 1861. Discharged, over-age, July 1864.

**Westmoreland, Lacy G.**—Private Aug. 24, 1861. Appears last on roll for Oct. 31, 1861.

**Whisenant, Adam (or Whistenant)**—Private Aug. 18, 1862. Died in Chimborazo Hospital at Richmond, Va. June 23, 1862.

**Whisenant, John B. (or Whistenant)**—Private May 16, 1862. Captured at Gettysburg, Pa. July 3, 1863. Paroled at Point

Lookout, Md. Feb. 18, 1865. Received at Boulware & Cox's Wharves, James River, Va. for exchange Feb. 20-21, 1865. No later record.

**Whiten, Calvin (or Whiting)**—Private Mar. 1, 1863. Killed at Deep Bottom, Va. Aug. 16, 1864.

**Whiten, Isaac L. (or Whiting)**—Private Aug. 24, 1861. Captured at Cedar Creek, Va. Oct. 19, 1864. Released at Point Lookout, Md. May 15, 1865.

**Whiten, Jackson Green (or Whiting)**—Private Mar. 1, 1863. Died at Newnan, Ga. Nov. 27, 1863. Buried there.

**Whiten, Oliver (or Whiting)**—Private Mar. 1, 1863. Captured and paroled at Hartwell, Ga. May 23, 1865. (Born in Habersham County, Ga. Feb. 7, 1831.)

**Whiten, William Frazier (or Whiting)**—Private Aug. 24, 1861. Died near Richmond, Va. July 20, 1862.

**Whitlock, George W. (or Whittock)**—Private Aug. 24, 1861. Admitted to Chimborazo Hospital #3, at Richmond, Va. May 16, 1862. Discharged on account of chronic rheumatism July 19, 1862.

**Wilbanks, Alvin D.**—Private Aug. 24, 1861. Roll for Aug. 31, 1864, shows him present. Pension records show he was wounded through right breast and arm in Virginia Apr. 1865, and was at home on sick furlough close of war. (Born in Franklin County, Ga. Oct. 7, 1840.)

**Wilbanks, Thomas L.**—Private Aug. 24, 1861. Died of smallpox Jan. 22, 1863.

**Wiley, Ebenezer**—Private Aug. 24, 1861. Killed at Sharpsburg, Md. Sept. 17, 1862.

**Wiley, Thomas**—Private Jan. 8, 1862. Captured at Cedar Creek, Va. Oct. 19, 1864. Released at Point Lookout, Md. June 22, 1865.

**Willis, William T.**—Private Aug. 24, 1861. Appointed Musician in 1861. Roll for Aug. 31, 1864, shows him absent without leave. No later record.
